
#### **Tradition**

#### What does Central Office Do for Me???

- 3. Provide a telephone contact service for AA meeting information and other information such as recovery places, other 12-step contact information, other Central Office numbers, etc.
- 4. Publish a monthly newsletter by and for our local fellowship with local events and articles by local AA members on the Steps, Traditions and Concepts.
- 5. Assist in forming new groups or help existing groups in carrying out our purpose.
- 6. Help in any way to carry out the sole purpose of Alcoholics Anonymous.
- 7. Attempt to unify our efforts to achieve this purpose.

#### **Step Six**

Were entirely ready to have God remove all these defects of character.

In looking back to the inventory and considering the scope of my defects, even though I totally accepted that my Higher Power was in fact God, it seemed highly unlikely that even He could totally remove my character defects. It is the search for perfection that grants us the power to redo our lives on a continuing basis. For many, it is the "search" that quiets the past fears and gives us the serenity to turn our will and our lives over to a Higher Power that is now and always has been at our side, even when the drinking drove us to what seemed like a loss of all hope. The removal of only one small defect, and you will be amazed at how much they weigh, will be replaced by the three most powerful forces in the universe-joy, love and peace. And they weigh even less than a small feather. Welcome to the start of a marvelous new life. The Steps are a continuation of an ever evolving life, one that sees us making strides forward, but be always aware that as humans we can stumble. This in no way affects our progress. One of the many values of Step Six is in the knowledge and certainty that it can, as all Steps, be used over and over again-each time knowing that it will work. Some defects can and do sneak back in, usually in the guise of something "new". Personally I have to remind myself that I rode that horse before and

trying again won't improve the ride. The defects will be removed. No matter how many times each of the Steps are used, they will not wear out, this Step in particular. There is a Power that guides our progress, one that is eternal and forever. May you find him now and all the days of your life..


When I got to A.A., it wasn't whether or not I believed in God that caused me problems with the steps—it was what I believed ABOUT God.


Some of my greatest disappointments have come from getting that which I insisted on having!

#### **Tradition Six**

In the time I have been around the program I have witnessed how well this tradition works in our fellowship due to the dedication of members who have many more years of sobriety than I do. When I hear discussions concerning questions of whether a situation falls in line with Tradition Six or not, there are often many opinions. Despite the diversity of ideas, I am always amazed and impressed by the commitment these fellow members have to keeping our primary purpose a priority. While it is important to be cautious when it comes to outside issues, it is also vital to be open minded and go to reliable sources to investigate whether some issue is truly a violation of this tradition before making a judgment. Fortunately, we have people with considerable knowledge of A.A. history and how our founders discovered through experience how to handle divisions and learned to keep our fellowship from giving into their enthusiasm for recovery by overreaching. The 12 X 12 uses words like cooperation to describe what our attitude should be towards others outside the program. Since we are working for the primary purpose of helping alcoholics find the help that we have been blessed to enjoy, an attitude of cooperation and tolerance is in line with this precious tradition.

#### The Twelve Steps in Plain English

- 1. Alcohol will kill me.
- 2. There's a Power that wants me to live.
- 3. Do I want to live or die? (if you want to die, stop here).
- 4. Write about how I got where I am.
- 5. Tell another person all about me (let god listen).
- 6. Want to change.
- 7. Ask a Power greater than me to help me change.
- 8. Write down whom I've hurt.
- 9. Fix what I can without hurting anyone else.
- 10. Accept that I'm human and will screw up. Fix it immediately.
- 11. Ask a Power greater than me to show me how to live.
- 12. Keep doing 1 through 11 and pass it on.

#### **Concept 6**

On behalf of A.A. as a whole, our General Service Conference has the principal responsibility for the maintenance of our world services, and it traditionally has the final decision respecting large matters of general policy and finance. But the Conference also recognized that the chief initiative and the active responsibility in most of these matters should be exercised primarily by the Trustee members of the Conference when they act among themselves as the General Service Board of Alcoholics Anonymous.

The Trustees of Alcoholics Anonymous are comprised of 21 men and women. Of those, 14 are members of Alcoholics Anonymous and seven are nonalcoholics. They are elected for their experiences in business and other professional needs in order to ensure that the mission of Alcoholics Anonymous is carried out throughout our service corporations noted below. Since the inception of the General Service Board (of which the Trustees act as individual members not as a group) the only changes have been how the Trustees are comprised, yet their duties have remained the same.

The Trustee members of the conference are held mainly responsible for all service activities including but not limited to The A.A. Grapevine, Inc and A. A. World Services Inc. They, of course, operate under the scrutiny and occasional direction of the Conference. However, our charters have been designed to give them a great deal of authority and responsibility in the absence of the Conference.

Much like the Steering Committee of an Alano Club is responsible for the upkeep of the building and paying of the bills, the Trustees have certain authority over various forms of service from Public Information to Literature to Finance & Budgeting.

As per the Conference Charter, they are given much freedom within all service activities. This is due to the rather large number of transactions involved in our world service operation. With the operation of the service corporations being such a large undertaking, it stands to reason that we would grant the Trustees a large amount of authority, as none but the Trustees could make such decisions to ensure that the message and growth of A.A. is not only sustained but increased.

As stated in the A.A. Service Manual, "From top to bottom, our whole service structure indeed resembles that of a large corporation. The A.A. groups are the stockholders; the Delegates are their representatives or proxies at the 'annual meeting'; our General Service Board Trustees are actually the directors of a 'holding company.' And this holding company, the General Service Board, actually owns and controls the 'subsidiaries' which carry on our active world services.

This very real analogy makes it even more clear that, just like any other board of directors, our Trustees must be given large powers if they are to effectively manage the principal world affairs of Alcoholics Anonymous."
